CONTRACT FOR TOKOMAIRO COMMUNITY RECREATION CENTRE TRUST INC. 24 HOUR ACCESS USERS

TERMS AND CONDITIONS

1. This agreement is between the applicant (you) and the Tokomairiro Community Recreation Centre Trust Inc. (TCRT) 24 Hour Access users.

2. This contract entitles you to use Tokomairiro Community Recreation Centre gym facilities 24/7

3. All memberships and payments made are non - refundable and non-transferrable.

4. Conditions of access - the fob is for your personal use only i.e., the named and contracted fob holder. YOU MUST NOT ALLOW ACCESS TO ANY OTHER PERSON.

5. Membership is restricted to 16 years and over. Please note the family membership is limited to 2 adults and 2 school age children living in the same household. Extra school age children will be charged at \$30 a month and children over 18 will be an additional \$50 monthly. Student members must leave the gym by 8:30pm, including those with 24-hour fob access. The only exception is when accompanied by a parent or guardian who is part of the same Family Membership.

6. Liability

There are significant and inherent risks involved in using a facility such as a gym/weight training area. You use the equipment voluntarily and at your own risk and as such the TCRT and its committee will not be liable for any loss, damage or injury of any kind to you or your property, however it arises.

If you cause any damage to the facility or equipment that is either deemed as deliberate or negligent, or a breach of the Toko Gym Rules you are liable for reasonable cost of repairs or replacement.

7. Your physical condition

It is your responsibility not to use any equipment or do any activity which may adversely affect any medical condition that you may have. If you have any health or medical concerns, you must discuss them with your doctor.

8. Video and Surveillance

TCRT gym uses video surveillance to monitor the entrance way and gym area. By signing this agreement, you acknowledge that by accessing the TCRT gym you will be subject to video surveillance and recording.

9. Disability

Any members with any disability (eg, wheelchair) must be accompanied by another adult in the gym. This must be discussed by TCRT management before membership is given.

10. Health and Safety

I acknowledge that before my access fob is activated, I will have been issued a copy of the TCRT Health and Safety Guidelines, and signed copy of the gym rules and signed copy of the 24 Hour Access users contract. No school uniforms are to be worn in the gym.

I am aware of the:

- Location of defibrillator - left hand wall beside disability toilet.
- Location of First-Aid kit - on bench in foyer
- Location of Fire Exit - back of gym on the left.
- Location of Fire Action Plan - on entrance foyer notice board and beside fire exit door at back of gym.
- Location of procedures in the event of an earthquake - on noticeboard in entrance foyer and noticeboard in the gym.
